

# **MEMORANDUM OF UNDERSTANDING**

BETWEEN

*BlueBells Group of School, Jhansi*

Represented by the Principal

AND

*Sharda Devi Degree College, Jhansi*

Represented by the Principal

This Memorandum of Understanding is intended to promote cooperation between Bluebells Group of School, Jhansi and Sharda Devi Degree College, Jhansi. The Faculty of Bluebells Group of School, Jhansi, represented by the Principal and the Faculty of Sharda Devi Degree College, Jhansi, represented by the Principal recognizing the benefits to their respective institutes from the establishment of institutional links, hereby agree to enter into this agreement for the following purpose.

## **1. PURPOSE OF AGREEMENT**

The purpose of this agreement is to develop academic and educational cooperation, establish a collaborative certificate program in (indicate area of cooperation) between the two institutes and to cooperate in their mutual interest for a range of higher educational activities.

## **2. AREAS OF COOPERATION**

Subject to the availability of funds, resources and approval of the authorised representatives Faculty of Bluebells Group of School, Jhansi and Faculty of Sharda Devi Degree College, Jhansi, both institutions agree to develop the following collaborative activities for the students of Department of Education :

- a. Conducting joint research and development project
- b. Cooperation in individual projects
- c. Organization of lectures, meetings, conferences and workshops
- d. Exchange of information, teaching materials, technology
- e. Providing opportunities for the students to give lectures
- f. Search for opportunities to collaborate in the future

### **3. IMPLEMENTATION**

All programs or activities implemented under the terms of this Memorandum of Understanding shall be mutually agreed upon in writing, including the necessary budget for the program of activity as the need may arise.

3.2 Each of the participating institutions shall be fully responsible financially for the activities carried out under its direction or by its staff, except as otherwise agreed by the parties.

3.3 The parties will designate one officer each who will develop and coordinate specific programs or activities between them.

### **4. INTELLECTUAL PROPERTY**

Intellectual property rights of work carried out at each partner institution shall normally vest with respective institutions.

### **5. DURATION AND RENEWAL OF AGREEMENT**

This Memorandum of Understanding will become effective immediately after signature by the representatives of both **Bluebells Group of School, Jhansi** and **Sharda Devi Degree College, Jhansi** for a period of 5 (five) Years and is subject to revision of modification by mutual agreement.

### **6. AMENDMENTS**

6.1 This Memorandum of Understanding may be amended by a written agreement signed by the representatives of both Institutes.

6.2 In the event of any unforeseen incident during collaborative activities both institutes agree to negotiate a mutually acceptable solution. Should any disagreement arise out of the application, interpretation or implementation of this Agreement, the institute shall endeavour to exercise best efforts to negotiate their differences.



### **7. TERMINATION OF AGREEMENT**




